- CBP20 grant approval received
 - Won the grant for \$5500 CBP20 2044 Installation of 9 kW Solar System at Balmain Public School
 - Need to apply to receive funding by March 2021 envisage the work happening in first half of 2021 but no discussions have happened with Inner West Council or BPS as yet!

Principal's Report - Annabel Yau

(Apologies from Maria Lambos who is currently organising and participating in a virtual Principals' Conference. Thank you to Annabel Yau, who is relieving in her position until her return on Friday.)

- Virtual Trivia Night: Huge thanks to the volunteers behind the hugely successful evening, with an incredible \$21,200 raised to support our wonderful school!
- Huge THANKS to our P&C executive for your continued support during this unprecedented year! It is such a testament to your passion and drive in supporting our kids and school! Thank you!



- Special THANKS to Alvin and Jen, who are sadly for us, leaving the Balmain Public School family. Both Alvin and Jen have been actively involved in supporting our school in a variety of ways. We will miss the Lau family and wish them all the very best in the future!
- COVID-19 & end-of-year events: requires 4 square metre rule for students, staff and parents/carers, both indoors and outdoors.
 - o Hall 28 capacity on floor and 7 on stage
 - New COLA capacity of 47
 - Mon 14 Dec Giving Tree Assembly senators from each class only 30 students - sitting under COLA, to present Salvation Army with gifts
 - Mon 14 Dec Year 6 Graduation 60 students only 47 under COLA + 13 behind
 - Celebration of Learning eNewsletter

Funding request for portable PA's submitted - both current systems not working properly and required for end-of-year events

APPROVED for \$2800.00 for P&C to fund – NOTE school needs to pay first and then get reimbursed from the P&C for this

- COVID-19 and 2021: My understanding is that there will continue to be guidelines we will need to
 follow in the new school year. As always, once this information is disseminated to principals, it will
 be communicated via SkoolBag
- Playground upgrade:
 - o 17m x 11m shade shelter *complete*
 - response to query from November meeting what's left to be spent, concern about size and not sympathetic to look of school
 - The school (not P&C) has paid for the new COLA and recent upgrades - to cater for students' need for active play (student input sought)
 - reason for size is to fit ALL students K-6 undercover together hall does not fit entire school - will allow K-6 assemblies in the future, as well as protection
 - Design consultation with heritage report recommendations and DoE
 - Active space (middle space outside toilet block) complete rubber balance beam and various half spheres (as per sensory space)
 - Climbing frame waiting for soft fall (rubber) to be laid at end of week temporary fencing due to be removed Monday 7 December
 - NB: From concern received via Shehana I have contacted the company regarding use of equipment whilst students lining up/walking past in the morning - has spoken to installer - Health & Safety concern
- **Planning ahead for 2021**: Traditionally, the P&C has supported various programs at the final (December) P&C meeting to commence the new school year. These include:
 - Classroom resources 2020 amount was \$500/class/semester x 15 classes Semester
 1 2021 \$7500 APPROVED for \$7500.00 for P&C to fund
 - Visual Arts program \$3000 for resources APPROVED for \$3000.00 for P&C to fund
 - Reading specialist support \$5000/term 1 day/week initially introduced for 1 term only, as well as in Term 1 of the following year. As results were successful, was increased to 3 terms' support in 2020. Again, this individualised support has been successful with our struggling readers. Is this something the P&C would like to continue supporting in 2021?

APPROVED for \$20,000.00 for P&C to fund this programme for the entire year 2021

(Noted from Shehana to plan ahead – what is needed etc for funding & planning)



• IT Levy:

02/12/20 \$23,619 - 288 students (out of 381) - approx. 76% 11/11/20 \$21,897 - 267 students (out of 380) - approx. 70% (September meeting \$13,123 - 160 students - 42% (August meeting \$9676 - 118 students - 31%)

Query – Alvin – in regards to the playground upgrade, has all \$\$ been spent/committed? This was confirmed from Annabel Yau that yes, all has been spent. Alvin – ultimately the P&C top ups what the school can't afford so need to understand the difference between what is funded from the government as a one-off – or if this is matched? P&C request to have input. Annabel – said will get Maria to respond.

• IT Audit: Sean Baumann

- Has done a stocktake to re-assess position
- o It will be a 4 year implementation to transition to BYOD
 - Laptops bought in batches since last meeting 13 laptops have died cost to replace is \$11,800.00
 - And 2 staff laptops also need replacing Alvin queried as to whether staff laptops are funded by the school? SB will check with ML as to where this is at as these ones have failed sooner
 - Looking forward, as laptops start to fail, what needs/volume should he come to the P&C with? P&C Treasurer (Alvin) replied that the school does not have to ask the P&C! Only need to inform the P&C of what has been spent and current balance on hand – assuming that this is covered by funds from the IT Levy. But need clarity around what is funded from where.
- o Where is current P&C opinion on BYOD at?
 - Shehana has not progressed as yet need to do survey monkey
 - Alvin needs to be linked to conversation around funding. Also commented that this year has been OK with not too much failing. (SB – yes agree, it is the newer generation of equipment. OK for this year).

ACTION – where is IT Levy at compared to previous years – do we need a final push? ACTION – Survey Monkey on BYOD
